This role involves close collaboration with senior leadership, clinical directors, affiliated practice plans and hospital CIOs, CMIOs, CISO, CFOs, IT vendors, and other key stakeholders to drive digital transformation and innovation. - Conduct regular risk assessments to identify vulnerabilities and ensure robust mitigation strategies.
- Develop and maintain incident response plans, including preparation, detection, containment, and recovery measures.

- Oversee the design, implementation, and maintenance of robust, scalable, secure IT infrastructure, while ensuring reliability and performance of networks, data centers, and cloud
